NALCO DELIVERS BEST-EVER Q3 FY26 AND NINE-MONTH PERFORMANCE

NALCO ACHIEVES RECORD Q3 FY26 RESULTS ; NET PROFIT AT ₹1,601 CRORE, NINE-MONTH PROFIT AT ₹4,098 CRORE

Operational Excellence and Market Strength Fuel NALCO's Record Production and Sales

National Aluminium Company Limited (NALCO), a Navratna Central Public Sector Enterprise under the Ministry of Mines and one of India's leading producers and exporters of alumina and aluminium, has reported the highest-ever quarterly net profit in its history, reflecting exceptional operational and financial performance. For the third quarter ended December 2025 (Q3 FY26), NALCO recorded a net profit of ₹1,601 crore, surpassing the ₹1,583 crore achieved during the corresponding quarter of the previous financial year. As per the reviewed financial results for Q3 FY26, taken on record by the Board at its meeting held today in Bhubaneswar, the Company reported a total income of ₹4,925 crore, compared to ₹4,761 crore in Q3 FY25.

aluminium cast metal, in addition to recording its highest-ever net power generation. During the same period, the Company also attained its highest-ever sales of alumina and aluminium metal, including the highest-ever domestic sales of aluminium, underscoring strong market demand and operational excellence.
